The club rental fee is \$55, and shoe rental is available for \$10. Prizes will be awarded to the winning foursomes and at designated holes for longest drive and closest to the pin.


You will need to register for any optional events for you and your spouse/companion. If you are golfing don't forget to enter your handicap and any rental needs.
