Dear Ambassador Lighthizer:

On behalf of the American Wire Producers Association ("AWPA"), we submit the following comments in response to the notice of the United States Trade Representative ("USTR") regarding the proposed modification of action in connection with its Section 301 finding that "acts, policies and practices of the Government of China related to technology transfer, intellectual property, and innovation . . . are unreasonable or discriminatory and burden or restrict U.S. commerce."

Further to the USTR's Section 301 determination regarding China² and previous actions and proposed actions to implement the USTR's determination,³ the USTR has proposed an additional duty of 25 percent *ad valorem*⁴ on imports of specific products from China, which are listed in the *Annex* to the *Notice*. These products are identified by their eight-digit subheadings in the *Harmonized Tariff Schedule of the United States* ("*HTSUS*").⁵ The AWPA respectfully urges the USTR to:

(a) include the carbon, stainless, and other alloy steel wire products listed in the *Annex* in the final list of imports from China which will be subject to any additional duty;⁶ and

(b) take action in the form of a 25-percent duty on these steel wire products.

The AWPA represents 40 independent producers of carbon, stainless, and other steel wire products as well as five integrated wire rod mills that also manufacture such downstream steel wire products. On their behalf and on behalf of their workers and communities in 35 states, the AWPA submits that the proposed duties on steel wire products will be both practicable and effective in obtaining the elimination of China's acts, policies, and practices which unfairly and unjustifiably burden and restrict U.S. commerce.

First, the USTR has noted in numerous reports to the United States Congress that China's illegal trade practices have encouraged the exportation of finished products, such as steel wire products, while discouraging the exportation of semi-finished products and raw materials.⁷ Specifically, the USTR has reported that China's manipulation of border taxes:

... encourage{s} the export of certain finished products over other finished products within a particular sector. For example, . . . China has targeted value-added steel products, particularly wire products and steel pipe and tube products, many of which ended up in the U.S. market. 8

At the same time, China's border tax regime:

... discourages the export of the relevant primary and intermediate products ..., resulting in increased domestic supply and lower domestic prices.⁹

The result has been a surge of imports of steel wire products of all types from China, ¹⁰ capturing more and more of the U.S. wire products market through the export targeting measures of the Chinese Government.

Second, China's extensive programs of government-supplied subsidies have also promoted the market penetration by imports of value-added Chinese products, such as steel wire products. In its most recent report on China's compliance with its obligations under the World Trade Organization ("WTO"), the USTR again found—as it has in previous reports—that "China continues to provide substantial subsidies to its domestic industries, which have caused injury to U.S. industries." Chinese government bodies at every level—central, provincial, municipal, and local—provide a broad range of subsidies that distort national and international markets and promote the building of excess capacity in the steel sector, including steel wire products. These subsidy programs have adversely impacted the American wire products industry, as demonstrated by the countervailing duty orders imposed by

the U.S. Department of Commerce ("Commerce") on a number of steel wire products from

China. For example, Commerce found countervailing duty margins ranging from 9.42 percent

to 45.85 percent on prestressed concrete steel wire strand, a countervailing duty margin of

62.46 percent on steel wire grating, and countervailing duty margins ranging from 7.85 percent

to 264.09 percent on wire shelving for kitchen appliances. 12

Third, without additional tariffs of 25 percent on imports of steel wire products from China, U.S. manufacturers of steel wire products are facing an untenable cost-price squeeze.

Chinese wire rod has been effectively eliminated from the U.S. market as a result of:

(a) China's own policies to discourage the export of inputs like wire rod;

(b) Triple-digit antidumping and countervailing duties on steel wire rod from

China;¹³ and

(c) The overlay of Section 232 tariffs. 14

These circumstances have encouraged the Chinese Government and its steel industry to

accelerate the shift to downstream steel wire products which are currently not covered by either

Section 301 or Section 232 duties.¹⁵ In addition, the Section 232 tariff of 25 percent *ad valorem*

severely restricts the availability of wire rod from other global sources. Consequently, both

the price and availability of steel wire rod in the U.S. market are adversely affected, increasing

the costs of U.S. producers of steel wire products as they attempt to compete with the flood of

imported steel wire products from China. Only the imposition of comparable tariffs of

25 percent on these steel wire products can restore a level playing field for American

wire products manufacturers.

Fourth, the proposed imposition of duties on steel wire products are practicable in terms

of ease of enforcement and effective in terms of the value of imports from China. Because China

is already a significant—and often the largest—source of imports of various types of steel wire

products, U.S. Customs and Border Protection ("CBP") is familiar with these products,

their import trends, and their Chinese suppliers. Any attempt to evade Section 301 duties would

be apparent and, thus, readily detectable. In addition, Section 301 duties on steel wire products

would affect approximately two billion dollars (\$2,000,000,000) worth of Chinese

exports, 16 thus representing a significant inducement for the Chinese Government to rescind

its unreasonable and discriminatory acts, policies, and practices which have imposed a burden on

and restricted U.S. commerce.

Finally, additional duties on steel wire products from China are unlikely to "cause

disproportionate economic harm to U.S. interests, including small- or medium-size businesses

and consumers" 17 because there is more than sufficient capacity in the United States to meet

domestic demand. The U.S. wire products industry has numerous plants throughout the country

to serve customers with products in the quantities and qualities required. Consequently,

additional duties on these steel wire products from China would NOT cause "disproportionate

economic harm to U.S. interests."18 The AWPA also notes that many of its members who

supply steel wire products are themselves small- and medium-size businesses which are

important sources of employment and income in their communities. Further, U.S. wire products

manufacturers support numerous other American companies in their supply chains for inputs and

services, including the domestic steel wire rod mills as well as manufacturers of machinery,

packaging materials, and other input materials.

In conclusion, the AWPA respectfully urges the USTR to recommend to the President

that:

(a) All steel wire products be included in the final list of imports from China

which are subject to additional duties, and

(b) The additional duties be in the amount of 25 percent *ad valorem*.

 \underline{any} economic harm to U.S. interests. Such duties would only benefit the United States, as shown

above.

President Donald J. Trump is Confronting China's Unfair Trade Policies





From now on, we expect trading relationships to be fair and to be reciprocal.

President Donald J. Trump

YEARS OF UNFAIR TRADE PRACTICES: China has consistently taken advantage of the American economy with practices that undermine fair and reciprocal trade.

- For many years, China has pursued industrial policies and unfair trade practices—including dumping, discriminatory
 non-tariff barriers, forced technology transfer, over capacity, and industrial subsidies—that champion Chinese firms and
 make it impossible for many United States firms to compete on a level playing field.
- China's industrial policies, such as its "Made in China 2025" plan, harm companies in the United States and around the world.
- · China imposes much higher tariffs on United States exports than the United States imposes on China.
 - China's average tariff rate is nearly three times higher than the average United States rate.
 - Certain products are even more imbalanced, for instance the United States charges a 2.5 percent tariff on Chinese
 cars, while China currently maintains a 25 percent tariff on cars from the United States.
- China has banned imports of United States agricultural products such as poultry, cutting off America's ranchers and farmers from a major market for their goods.
- China has dumped and unfairly subsidized a range of goods for the United States market, undermining America's domestic industry.
 - In 2018 alone, the Trump Administration has found dumping or unfair subsidies on 13 different products, including steel wheels, cold-drawn mechanical tubing, tool chests and cabinets, forged steel fittings, aluminum foil, rubber bands, cast iron soil pipe and fittings, and large diameter welded pipe.

- In January 2018, the Trump Administration found that China's overproduction of steel and aluminum, and the resulting impact on global markets, is a circumstance that threatens to impair America's national security.
- The United States has run a trade in goods deficit with China for years, including a \$375 billion deficit in 2017 alone.

UNDERMINING AMERICAN INNOVATION AND JOBS: China has aggressively sought to obtain technology from American companies and undermine American innovation and creativity.

- The cost of China's intellectual property theft costs United States innovators billions of dollars a year, and China accounts for 87 percent of counterfeit goods seized coming into the United States.
- United States Trade Representative's (USTR) Section 301 investigation identified four of China's aggressive technology policies that put 44 million American technology jobs at risk:
 - Forced technology transfer;
 - Requiring licensing at less than economic value;
 - · Chinese state-directed acquisition of sensitive United States technology for strategic purposes; and
 - · Outright cyber theft.
- China uses foreign ownership restrictions, administrative review, and licensing processes to force or pressure technology transfers from American companies.
 - China requires foreign companies that access their New Energy Vehicles market to transfer core technologies and disclose development and manufacturing technology.
 - China imposes contractual restrictions on the licensing of intellectual property and technology by foreign firms into China, but does not put the same restrictions on contracts between two Chinese enterprises.
- China directs and facilitates investments in and acquisitions of United States companies to generate large-scale technology transfer.
- China conducts and supports cyber intrusions into United States computer networks to gain access to valuable business information so Chinese companies can copy products.

STANDING UP TO CHINA'S UNFAIR TRADE PRACTICES: President Trump has taken long overdue action to finally address the source of the problem, China's unfair trade practices that hurt America's workers and our innovative industries.

- In January 2018, the President announced his decision to provide safeguard relief to United States manufacturers injured by surging imports of washing machines and solar products.
 - This was the first use of Section 201 of the Trade Act of 1974 to impose tariffs in 16 years.
 - These actions responded to injurious trade practices by China and other countries, including attempts to avoid legally imposed antidumping and countervailing duties.

- Following the decision, Whirlpool announced 200 new jobs in Ohio.
- USTR and the Department of Commerce are working together to defend the right of the United States to continue treating China as a non-market economy in antidumping investigations until China makes the reforms it agreed to when it joined the World Trade Organization (WTO).
- President Trump's Administration has successfully litigated WTO disputes targeting unfair trade practices and upholding our right to enforce United States trade laws.
 - In February 2018, USTR won a WTO compliance challenge against China's unfair antidumping and countervailing duties on United States poultry exports and China announced the termination of those duties.

PROTECTING AMERICAN INNOVATION AND CREATIVITY: President Trump has worked to defend America's intellectual property and proprietary technology from theft and other threats.

- In August 2017, the Administration initiated a Section 301 investigation into China's practices related to forced technology transfer, unfair licensing, and intellectual property policies.
- After USTR completed its Section 301 report in March 2018, the President directed the agencies to explore numerous
 actions to protect domestic technology and intellectual property.
- Under President Trump's leadership:
 - The United States will impose a 25 percent tariff on \$50 billion of goods imported from China containing industrially significant technology, including those related to the "Made in China 2025" program. The final list of covered imports will be announced by June 15, 2018.
 - USTR will continue WTO dispute settlement against China originally initiated in March to address China's discriminatory technology licensing requirements.
 - The United States will implement specific investment restrictions and enhanced export controls for Chinese persons and entities related to the acquisition of industrially significant technology. The list of restrictions and controls will be announced by June 30, 2018.
